

National CAPACD Request for Proposals AAPI Community Resilience Fund: Round 2

RFP Release Date: Monday, August 3, 2020 RFP Due Date: Friday August 14, 2020, 8pm PDT

1. SUMMARY AND PURPOSE

The COVID-19 health crisis has dramatically changed the economic and social landscape of our nation, with communities of color particularly hard-hit by the pandemic. Asian American and Pacific Islander (AAPI) communities in particular have endured the impacts of this pandemic longer than most communities – a direct result of xenophobia and racism.

National CAPACD's network of community-based organizations have risen to the challenge of serving, mobilizing and protecting their communities in many inspiring and innovative ways. In acknowledgement of the additional economic strain this work has placed on organizations and communities, National CAPACD has raised funds from philanthropic sources to establish an *AAPI Community Resilience Fund*.

The AAPI Community Resilience Fund will provide general operating support to organizations that prevent displacement of the most vulnerable AAPIs from their communities in the wake of the COVID-19 pandemic. We seek to stem the tide of displacement that will most impact low-income tenants, homeowners and small businesses during this public health and economic crisis. The fund will be administered in multiple rounds throughout 2020.

Round 2 will award approximately **10 grants of up to \$15,000 each**. Applicant organizations must be implementing **at least one of the following pandemic relief activities** in order to be considered:

- (1) Outreach, Information, and Services in Multiple Languages on Resources and Strategies related to COVID-19 and relief efforts: to reach the diversity of the AAPI community- using tools such as video, social media, and partnerships with ethnic media.
- (2) In-language counseling, case management and/or financial relief for low-income, LEP tenants and homeowners: to mitigate economic loss and support increased need for services in areas such as (but not limited to) accessing unemployment and public benefits, navigating mortgage relief, and direct relief to those left out of public support.
- (3) In-language counseling, technical assistance and/or financial relief to small businesses and sole proprietors: to mitigate economic loss, facilitate access to capital and federal relief programs, and support increased need for services in areas such as (but not limited to) reopening or adapting business models to operate in alignment with social distancing and stay-at-home orders.
- (4) Tenant and neighborhood organizing: to mobilize tenants and small businesses at-risk of eviction and default for collective action and policy change, organization and management of mutual aid funds, and other community driven strategies to provide relief and mediation as needed.

Although not a required activity, grantees will be highly encouraged to document and report any hate crimes or incidents against AAPIs.

The AAPI *Community Resilience Fund* is made possible with generous support from the JPMorgan Chase Foundation, Wells Fargo Foundation and Citi Community Development.

2. GUIDELINES FOR SUBMISSION AND ASKING QUESTIONS

All applications are due by Friday August 14, 2020 at 8pm PDT and should be submitted to RFP@nationalcapacd.org. Applications must be complete, including a narrative and other required supporting documentation, in order to be considered. Applicants that have submitted late or incomplete applications will be notified so that they may re-submit for the next round of funding.

Questions about the RFP should also be submitted to <u>RFP@nationalcapacd.org</u>. Questions received through other avenues (e.g. - phone calls, emails directed to individual National CAPACD staff) will not receive a direct response and will instead be forwarded on to <u>RFP@nationalcapacd.org</u>, which will delay the response time to any questions.

3. APPLICATION TIMELINE

- RFP deadline Friday August 14, 2020, 8pm PDT
- Sites selected and notified, contracting begins week of September 4, 2020

4. GRANT PERIOD

Awards from Round 2 will have a grant period of July 1, 2020 to December 31, 2020

5. GRANT AWARD DETAILS

- Round 2 will make a total of \$150,000 available to support up to 10 grants total
- Maximum grant size is \$15,000
- Funds will be awarded as general operating grants

6. REQUIRED ACTIVITIES

- Attendance is required for monthly videoconference calls and any additional orientations or trainings
- Sub-grantee must utilize tools for tracking populations served, impact of work
- Sub-grantee must collect client stories to document impact
- Sub-grantee must submit final report
- Sub-grantee must work closely with National CAPACD to document and disseminate outcomes (if appropriate) with local media, asset building practitioners, federal agencies and elected officials

7. ELIGIBLE APPLICANTS

- This RFP is open to all members of National CAPACD's network.
- Applicants are not required to be a member of National CAPACD to respond to Requests for Proposals but are highly encouraged to become member organizations.
- Please refer to National CAPACD's Grant Guidelines PDF under section "General Eligibility Criteria" to see if your organization is able to apply for a grant.

8. SELECTION CRITERIA
