National Housing Counseling Program - National CAPACD is a housing counseling intermediary that supports a network of trusted community-based organizations (CBOs). These organizations deliver culturally and linguistically appropriate housing counseling services to the homeless, low- and moderate-income renters, homebuyers, and homeowners. We provide grants and training resources that support housing counseling services, outreach activities, capacity building, and training. We use a peer-to-peer approach to share best practices and strategies among CBOs. In 2022, the network of 12 organizations served over 5,000 low and moderate-income AA and NHPIs, helping to ensure individuals and families could remain in their homes or build their assets through homeownership.

Small Business Network / Creative Placemaking - National CAPACD is building the capacity of trusted, culturally competent, and linguistically capable community based organizations through a combination of group training and individualized technical assistance focused on business counseling and micro-lending practice, as well as trainings and opportunities for peer sharing focused on planning and policy to support neighborhood economic stabilization.

4c (Code:) (Expenses \$ 658,604. including grants of \$ 561,603.) (Revenue \$)

AAPI Community Resilience Fund - In response to the COVID-19 pandemic, National CAPACD launched the AAPI Community Resilience Fund. This Fund drove national resources to local, low-income AAPI communities with limited access to federal and philanthropic funding and whose needs are typically ignored by mainstream relief and recovery efforts. In 2022, the Community Resilience Fund focused on Cross-Racial Allyship, Healing, and Solidarity. The fund provided sub-grants to 21 AA and NHPI organizations across the country to support their own racial healing and organizational anti-racism work and implement activities that build multi-racial coalitions and advance a progressive agenda for equitable and racially just community reinvestment.
